General Chinese Visa Information:

- You will be applying for the Student Visa (X1 for more than 6 months; X2 for less than 6 months).
- Mailed applications are not accepted-you must apply in person or through a reputable visa service (CGSE recommends <u>Washington Passport and Visa Service – New York Office</u>, contact information below).
- You should apply for a multiple-entry visa.
- You should submit <u>a copy</u> of your Peking University acceptance letter—the consulate will keep it—carry the **original with you** to Beijing.

Step 1: Gather necessary documents

- See checklist on Page 2 for necessary documents.
- CGSE suggests you use Washington Passport and Visa service to process your documents.

Step 2: Apply for your VISA

Chinese Visa Application Form http://www.wpvs.com/UserFiles/File/China V isa Application Form 2013.pdf	CGSE (On WPVS Website)	Included in your visa packet. The application form must be filled out completely; For questions, contact CGSE or WPVS New York, if you are using their service.
Signed Passport	You	Must be valid until July 31, 2016 (for Fall Semester ONLY students) or January 31, 2017 (for Academic Year ONLY students); must have at least one blank page in order to affix the visa.
One (1) 2-inch square photograph	You	Must be taken within six months of application; must be glued to the application form, not stapled or taped.
Letter of Acceptance from Peking University AND Original Visa Application from Peking University (JW 201)	CGSE or mailed to your home directly from Peking U.	You must have these documents in order to apply for the visa. DO NOT LOSE THESE, they are extremely difficult to replace. Submit a COPY of your Acceptance Letter, carry the original with you to Beijing.
Letter of Acceptance from Dickinson College	CGSE	Dickinson College will write a letter of support for your studies at Peking University.
Flight Itinerary	You	Make sure this is a confirmed, booked flight.
Pre-paid Express Mail Envelope Self-Addressed	You	Made out to you for the return of your passport & visa with sufficient postage enclosed (\$19.99). MUST use U.S. Express Mail envelope, as the Consulate does not use FedEx, UPS or other third party mail services for returning passports.
Proof of ID/US Residency	You	For US Citizens, copy of driver's license. *For non-US citizens; must bring either Green Card or valid I-94 and US resident visa (F or J visa holder must bring an I- 20 or DS-2019 plus one copy).
Fee	You	Money Order Check Embassy/Consulate website for fee details. Or WPVS if you choose to use their service: WPVS-New York cost will be \$290.00 + \$23.00 (For 7-10 business day service) or \$340.00 + \$23.00 (for 3-5 business day service)
