All Students MUST have a student visa to participate in this program.

Students arriving without proper documentation to obtain a student visitor visa at their point of entry will be sent home by immigration officials at your own expense.

YOU are solely responsible for gathering and maintaining the necessary documents needed to be GRANTED A VISA UPON ARRIVAL for your program.

Please take this process seriously.

THESE GUIDELINES ONLY PERTAIN TO US CITIZENS STUDYING IN THE UK FOR ONE (1) SEMESTER

What You Will Need TO DO:

- > CONSULT and READ information on the STUDENT VISITOR process at the UK website.
- ➤ **GATHER** all of the supporting documentation (and copies!) for your visa application.
- ➤ **CARRY WITH YOU** all required documents for your student visitor visa when you travel to England.
- ➤ **PRESENT** all required documentation when you pass through immigration upon arrival in England.
- ➤ **IF YOU ARE A US CITIZEN** and only studying in the UK for 6 months you **DO NOT** need to apply for a visa ahead of your arrival (you are considered a 'non-visa national').
- ➤ IF YOU <u>ARE NOT</u> A US CITIZEN you <u>may need</u> to APPLY for a visa you need to **DO**YOUR OWN RESEARCH at the UK Embassy in your country of citizenship

Step 1: Prepare by Collecting Necessary Documentation

- NOW! Consult this website: www.ukvisas.gov.uk
- Familiarize yourself with the requirements of the student visitor visa program. Please note as you are reading the requirements that you do not need to complete Appendix 8!
- ➤ By **December 1, 2013**: make sure you have received and/or obtained all of the necessary documents to be granted a student visitor visa when you arrive in the UK.
- Use checklist (on back) in preparation for your trip.
- **KEEP** all of your documentation in a safe place. Some documents will be very difficult to replace if lost.

Step 2: Travel with your Passport and Documentation with You

Take your passport and documents with you. **DO NOT** pack them in your checked baggage!

Bank Statement	You (If you receive financial aid, a financial aid statement will be included in your supplemental package)	The statement must show proof of funds in a bank account of the person funding your trip. The bank statement must show what has been in and out of the account up to the previous six months and naming the account holder. If this is your parent(s), you must provide an accompanying letter of support from the parent/guardian (whose name IS listed as the account owner) to attest that the student has access to these funds, if necessary. If you are receiving financial aid, you should also provide your statement of financial aid.
